THE HARSIN FAMILY OF NEW YORK CITY

The Reverend Warnardus Harsingh, Hassing or as later used Harsin, died in December 1663 during passage from Amsterdam to New Amstel, the South River Colony in what is now Delaware, where he was sent as minister by the Amsterdam Classis of the Protestant Reformed Dutch Church (Albert Eekhof, The Dutch Reformed Church in North America 1:264; Hugh Hastings, ed., Ecclesiastical Records of the State of New York, comp. by Rev. Edward T. Corwin, 1:549–550, 553; 6:4408).

John O. Evjen, Scandinavian Immigrants in New York, 204, derives this family from the village of Hassing in Denmark, but it seems Louis P. DeBoer is more likely correct in his statement ("Selyns-Kock-Webber and Other Family Relations," Rec. 57:374) that they were originally from Antwerp, moving because of the Inquisition to Meurs near Roermond. DeBoer notes this manor later came under the ownership of the city of Amsterdam, which also owned the South River Colony, and that the Rev. Warnardus Harsin was of a branch of the family evidently living by the mid 17th century at Breucklen in Utrecht province. The parish registers for Breucklen's Reformed congregation are not available before 1686 nor apparently are notarial records before 1691. Court records do exist from 1642, but have not been examined.

DeBoer further suggests, correctly it would seem, that the Bernardus, Johannes, Geertruy and Heyltje Hassing who first appear in the records of the Dutch Church at New York City in and shortly after 1666, were surviving children of the Rev. Warnardus Harsin. The church's membership list may allow us to note another child, Anna, whose name is entered the same date as those of Wolfert Webbers and Geertruyd Hassing, 15 July 1668, but is not thereafter of record.

Brief accounts of this family are found on the children of Geertruy, wife of Wolfert Webber (Rec 57:30-32, 38-42); the children of Bernardus, who married Aeltje, daughter of Jacob Wolphertse Van Kouwenhoven (Rec. 71:73): and a more extended although incomplete treatment of the descendants of Jacob, son of this last named couple (Hopper Stryker Mott, *The New York of Yesterday. A Description Narrative of Old Bloomingdale* [1908], 126-134, 308-309). The following material covers other members of this family, which flourished in New York City, established a branch at Albany, contributed leadership to the Dutch church from time to time, lent their name to that area of Manhattan known as Harsenville, and sent several representatives to the midwest at an early date. Several misstatements by Mott can be corrected.

In this account baptisms, marriages and deaths are found in the published records of the Dutch Church at New York unless otherwise noted.

Children of the Rev. Warnardus Harsin, born in the Dutch Netherlands, date and order unknown:

 - v. Geertruy, married by 1666, Wolfert Webber, son of Wolfert Webber and Anna Wallis. She and husband became members of the New York Dutch Church in 1668 as above noted, together witnessed the baptism of a grandchild 6 Dec. 1696, and she was dead before 15 April 1715 when Wolfert made his will in NYC's Out Ward, leaving among other bequests, silver cups to granddaughters Geertie Fonteyn and Geertie Minthorn in virtue of their "being called after the name of my wife Geertie Webbers, deceased" (WNYHS 11:33-34, proved 5 Feb. 1717/8). See the Rec. 57: 30-32, 38-42 on this family.

- 1. Bernardus² Harsin (Rev. Warnardus¹) was identified as from Breucklen, province of Utrecht, 7 July 1669 when he married at New York, Aeltje Couwenhoven (MDC, 34), daughter of Jacob Wolpherstse Van Kouwenhoven and Hester Jansen, born there 20 and baptized 27 August 1645 (BDC 1:19). Her ancestry, as noted, is found in the Record (70:231-235, 353-354; 71:73). Bernardus acted as witness at the Dutch church 13 November 1666 (for his sister Geertruy's eldest child, named after their father), 12 August 1669 (with his wife, but recorded as "Bernardus Biscop"), 2 January 1670 and 5 November 1671 (BDC 1:85, 95, 97, 104). He and his wife became members of the New York church 28 February 1683 (Rec: 9:168), and were listed among the members in 1686 as living on the south side of Wall Street (HSYB 1916, 25).

No death or probate record has been found, but Bernardus died, perhaps at Flatbush, before 29 July 1701 when "Garrat Hossen, son of Benhadas Hossen, deceased," indentured himself to Francis Vandike, Gunsmith, in the presence of Jacob Hossen (his elder brother) and William Sharpas, for five years from 1 August 1701 (recorded 10 January 1703, NYHSC 1885, 607).

Teunis Bergen, Genealogical Register of Kings County Before 1700 [1881], 133, hereafter "KCo," says Bernardus Haszingh "(as he signed)" and wife were members of the Flatbush Dutch Church in 1677 when entered in its records as removed, and cites Flatbush Liber AA:119 to show that on 20 April 1680

Bernardus agreed to buy a house and two ordinary building lots in Flatbush from Jan Gerretse Van Marcken for 1,200 guilders.

- 2. Jacob³ Harsin (Bernardus², Rev. Warnardus¹) was baptized at New York 22 September 1672 (BDC 1:107) and died before 4 March 1750 when Jacomyntie Boke "wed. van [= widow of] Jacob Harsing" witnessed the baptism of a grandson (BDC 2:157). On 30 August 1698 "Jacob Hassing, Carpenter" was made Freeman of New York City (NYHSC 1885, 66), and as above noted he witnessed his youngest brother Gerrit's indenture 29 July 1701. He married three times. First, 30 October 1700 (int. 5 October) Emerentia Van Gelder (MDC, 93), daughter of Jan Van Gelder and Tanneken Mantenac, baptized at New York 29 December 1680 (BDC 1:145); second, 16 July 1711 (int. 26 May) Cornelia Dykman of Albany (MDC, 115), daughter of Cornelis Dyckman and Jannetje Dirckse Claessen, and one of the several children not named in the will her father made at New York City 6 Sept. 1711 (WNYHS 11:4); third, 21 October 1721 (int. 8 October) Jacomyntje (Bocke) Brevoort (MDC, 136), daughter of Abraham Bocke and Tanneken Adriese Van Driese, and widow of Hendrick Brevoort. Henry Brevoort's will, made 10 May 1718 in the Bowery of New York City's Out Ward, mentions first wife Mary, children, and wife Jacaminite, who was to have his estate as long as she remained his widow (proved 16 July 1718, WHYHS 11:26). A deed of 29 November 1718 identifies "Jacomite, widow of Hendrick Brevoort" as one of the children and legatees of Abraham Bokee late of Fresh Water Kill, deceased, as named in his [apparently unrecorded] will made 2 October 1702 (NYC Conveyances 30:202).

- 3. HEYLTIE³ HARSIN (Bernardus², Rev. Warnardus¹) was baptized at New York 7 February 1677 (BDC 1:126) and died there 29 June 1750, as "Heyla Aartse" (HSYB 1899, 139). She married by 1702 David Aartse or Aertson, son of Jan Aertsen* and Arianetje Cornelis, "of the Ferry," at Brooklyn (KCo, 206), baptized at Flatbush 18 December 1681 (HSYB 1898, 123), died before 22 August 1732 when "Aeiltje Harsing wed. van David Aarssen van Breukelen" became a member of the New York Dutch Church (Rec. 60:280). By his father's 11 August 1707 will David Aertse received his father's house and garden at the Ferry which he was then occupying. He was captain in the 7th company of a militia regiment in Kings County in 1715 (DHNY 3:116).

- 5. Gerrit³ Harsin (Bernardus², Rev. Warnardus¹) was baptized at Flatbush, Long Island, 20 January 1682 (HSYB 1898, 124) and died testate at New York City 4 August 1753 (HSYB 1899, 167). He married, "of Flatbush," at New York 28 June 1707 (int. 6 June), Engeltje Burger (MDC, 107), daughter of Joris Burger and Lysbeth Lubberts, baptized at New York 3 February 1689 (BDC 1:188), died after 7 September 1754 when, "widow & relict," of Gerret Harsin she conveyed a dwelling house and lot in the East Ward, on the northeast side of Little Queen Street, to Lawrence Read for 490 pounds (NYC Conveyances 34:92).

^{*}Bergen (KC.) mistakenly thought he was a son of Aert Middagh.

As noted, Gerrit was apprenticed 29 July 1701 to learn the trade of gunsmith from Francis Van Dyke, and he undoubtedly met his wife Engeltie in this household since she was half-sister to Francis' wife Fytje Dircks, daughter of Lysbeth Lubberts by her first husband Dirck Evertszen Fluyt (MDC, 66 & 96; BDC 1:125).

Gerrit Harsin was chosen one of the "church masters" of the New York Dutch Church 21 October 1731, and on 28 June 1739 chosen as ruling elder to replace Matthew Clarkson, deceased (Corwin, op. cit 3:2101, 4:2722). He is probably the man in 1738 listed in Gerard Beekman's Militia Company as sergeant, with William Gilbert whose daughter married Gerrit's son George in 1746 (O'Callaghan, op. cit. 4:139). By an unexamined deed of 25 August 1744, not recorded until 3 June 1824, Gerrit Harsin and wife Engeltje conveyed land to Simon Johnson (NYC Con. 175:402).

As "Gunsmith, of New York City," Gerrit made his will 15 May 1753 leaving his entire estate to wife Engeltje, to be divided at her death equally among "my three children, Bernardus and George Harsin and Engeltie the wife of Peter de Wint." He nominated his wife and sons as executors, and they took oath as such before Goldsbrow Banyar 29 August 1754 (original, item 844, Historical Documents Collection, Queens College [now N.Y. State Library, Albany]; abstract, WNYHS 5:25). On 4 October 1763 Garret Harson of New York City, Baker, "Grandson of Garret Harsin late of New York City, Gunsmith," was appointed administrator of the estate after charging it had been "unadmin. by Engeltje Harsin, Bernardus Harsin and George Harsin" (NYC Admins. C:343; abstact, Scott, Gen. Data from Admin. Bonds, 64). An advertisement in the New York Gazette-Mercury on 15 April 1771 for sale of a house and lot "in the upper end of Smith St., NYC," of Garret Harsin, dec'd, now "in possession of Mr. Norris, barber," advised interested parties to see Garrit Harsin in French Church Street (Scott, Gen. Data from Colonial N. Y. Newspapers, 153).

THE HARSIN FAMILY OF NEW YORK CITY

6. Bernardus⁴ Harsin (Jacob³, Bernardus², Rev. Warnardus¹) was baptized 8 February 1702 (BDC: 1:281) and married in the Dutch Church at Albany, 12 February 1736/7 (lic. 17 Jan.), Catharina Pruyn (HSYB 1906, 6), probably daughter of Samuel Pruyn and Maria Bogart. Bernardus and his wife had children baptized at Albany in 1738 and 1741, at New York City in 1746 and 1748 and again at Albany in 1752 and 1754. Bernardus served as one of the fire masters in Albany's second ward for a year beginning 8 November 1755, and is listed among pew holders in the Dutch Church, his seat being transferred in 1766 to "Jacob Harsen, his son," while that held by "Catharina Bd. Harsen" went to Elisabeth, wife of Jacob Ja. Van Woert (Munsell, Collections on the History of Albany 1:99, 80b, 73).

- 7. AALTJE⁴ HARSIN (Jacob³, Bernardus², Rev. Warnardus¹) was baptized at New York City 16 September 1705 (BDC 1:311) and was living there as late as 1 May 1748 when as "Aaltje Harsing, wed. van Marinus Egt" she witnessed a baptism for her brother Bernardus (BDC 2:142). As "Altie Harrse" she became a member of the NY Dutch Church 23 February 1725 (Rec. 60: 157), and she married there 7 November 1725 (lic. 6 Nov.), MARINUS ECHT (MDC, 144), son of William Echt and Marrittie Van Dyk, baptized there 30 July 1704 (BDC 1:300), died before 25 November 1740 when "Aaltje Harsine wed. van Marinus Eght, van Curacao" again joined the NY Dutch Church (Rec 60:347). Marinus' mother was probably a sister of Frans Van Dyk whose wife's half sister, Engeltje Burger, married #5 Gerrit Harsin.

Maurice Eight, Blacksmith, became Freeman of New York City 23 January 1727/8 (NYHSC 1885, 110), and he and Aaltje witnessed baptisms 2 October

1728 and 19 April 1731 (BDC 1:486, 2:12). On 20 and 21 May 1733 Maurice Eght (he signed "Morris Eight") and wife Aeltie deeded Thomas Hunt, Marriner, all of New York City, a water lot there containing a new dwelling-house, smith's shop, stable and new wharf, for 700 pounds, 5 shillings (wit. by Garret Harsen, William Grant, Isaac Johnson, NYC Conveyances 30:501, 503).

Aaltje, as "wed. van Marinus Egt" witnessed baptisms 25 Dec. 1743, 2 March 1745 and, as already noted, 1 May 1748 (BDC 2:106, 123, 142). Evidence suggests she may have married shortly after this last date (2), JACOB BEMPER, who died 9 January 1750 (HSYB 1899, 144), witnessed as "Aaltje Binmaar" a baptism at Albany 12 August 1750 for her brother Jacob, and married (3) as "Aaltje Bimmer, wed.," 20 October 1750 (int. 19 Oct), "HENDRIK SEDUM, wedr." (MDC, 183). On 17 April 1751, "Aaltje Harsing, huis v. van Hendrik Sedam" witnessed at the New York Dutch Church (BDC 2:166), and on "22 8ber 1758 Aaltje Harsin wed. v. Hendrik Sudam v. Albane" was entered on its membership list (Record 60:172). The death of "the widow of Hendrik Sedam" was entered in the church records 11 April 1759 (HSYB 1899, 195). No children are known.

8. Johannes⁴ Harsin (Jacob³, Bernardus², Rev. Warnardus¹) was born 18 February [Mott] and baptized 21 February 1714 (BDC 1:373), died there 4 March 1774 [Mott, but probably 1775], married there twice in the Dutch Church: first, 14 May 1743 (int. 13 May), Margarita Van Vegten (MDC, 170), daughter of Teunis Van Vegten and Annatje Heermans, baptized there 14 September 1720 (BDC 1:422), died there 18 December 1743 [Mott], presumably in childbirth as her daughter and namesake was baptized six days later. Johannes married second, 19 March 1749 (int. 17 March), Rachel Dyckman (MDC, 180), daughter of Nicholas Dyckman and Anneke Sevenhoven, born 23 February 1720 and died 18 July 1772 [Mott], named in her father's 29 May 1758 will which also named son-in-law John Harsen as one of the executors (WNYHS 5:257).

John Harsin made his will at Bloomingdale 2 December 1774 (proved 12 May 1775, WNYHS 8:262-263), naming eldest son Jacob, son Cornelius, and daughters Cornelia, Maria and Ann. He left his large Dutch Bible to the church at Harlem, left monies due from his "mother-in-law Ann Cowenhoven" to his children [Annatje, mother of his first wife Margrietje, married in 1730 as her second husband Jacob Kouwenhoven, MDC, 161], and nominated his sons as executors. On 9 April 1775 Ann Covenoven of the Out Ward of New York City, widow of Jacob Covenoven, left among other bequests in her will, ten pounds apiece to Jacob, Cornelius, Marite, Cornelia and Annatie Harse, "the children to John Harse, lately deceased" (WNYHS 10:273-274).

Warnardus¹) was baptized at New York City 7 June 1721 (BDC 1:428), died there 28 August 1758 (HSYB 1899, 167), married there in the Dutch Church, 13 July 1746 (int. 11 July), Maria Gilbert (MDC, 175), daughter of William Gilbert and Maria Van Zandt, baptized there 11 January 1727 (BDC 2:471), died there 26 May 1764, "widow of Joris Hasser" (HSYB 1899, 167). "George Horsen [sic], Gunsmith," was made Freeman of New York City 31 May 1749 (NYHSC 1885, 167), and on 28 February 1749/50 appointed one of the city's public measurers (MCC 5:287). His surviving children were named in the will of their maternal grandfather, William Gilbert, 5 April 1769 as children of his deceased daughter Maria, late wife of George Harsen, "namely Angletie, George, Aaron and Gerret" (original, item #3911, Historical Documents Collection, Queens College, now at New York State Library, Albany; abstract, WNYHS 14:100-101).

This couple had a child baptized at Albany in 1765, and in 1766 Jacob received his father's seat in the Dutch Church (Munsell, *ibid*. 1:80b), but he is not found in the Albany records after that date. Milo M. Quaife, The John Askin Papers (Burton Historical Collection, 1928) I [1747–1795): 309, says Jacob Harsen was living in Detroit as early as 1779 and as late as 1797, subsequently settled

Jacob and Catherine were among those involved in extensive litigation regarding the estate of Catherine's grandfather Cornelius Cosine the Elder, of Bloomingdale, as late as 4 July 1798 and 18 April 1808 (Scott, Chancery Court Records, op. cit., 102, 174-175). Jacob's will (NY Wills 74:215), dated 26 March and proved 15 September 1835, names wife Catherine, son Cornelius, and several grandchildren.

He was baptized at the Dutch Church 10 September 1755 (BDC 2:205) and married by New York license 25 January 1782, Anne Hopper, daughter of Wessel Hopper and Anneke Dyckman, baptized there 23 February 1763 (BDC 2:264), death date not given. Mott gives a second marriage for Cornelius, "in Bloomingdale," 27 September 1819, to Mary Skelding, and says it is recorded in Bailey's *History of Danbury, Connecticut*, page 40. Neither Cornelius, nor Mary's name is indexed in this book, nor is the marriage noted on p 40. Anne Hopper is named in her father's will of 18 October 1777 (WNYHS 15:211). The printed 1790 census shows Cornelius (p. 137) in New York City's Harlem Ward with 1/2/3.

She is assumed to be the woman who married, both "of the outward of NYC," at the Dutch Church 3 October 1782 (NY lic. 30 Sept.), James Rykman (MDC, 251), possibly the son of Jacobus Rykman and Maria Van der Hoef, baptized 11 July 1759 (BDC)

2:237), and living in 1790 (op. cit., p. 128) in the Out Ward with 1/2/3, next to Jacob Horsen, though another James Rickman is listed with 1/-/3 on the same page.
