On May 15, 1847 an estate sale was held of the estate of Joseph Thornton. The major purchasers of the family items, farm equipment and live stock were the sons of Joseph [- Henry - William - Calvin - James - Edward and George. The only one not mentioned at this event was Thomas Thornton.

Buried Rochport Cemetery with the death date 3-21-1849 which is in obvious conflict with the probate records as above. Died at 64 years of age.

The Founding of Boone County

The following is directly quoted from the History of Boone County, Missouri originally published in 1882. It is purported to be "written and compiled from the most authentic official and private sources". The style may be slightly old fashioned and in some places quite "full of themselves", but nevertheless it is entertaining and very informative reading.

Around the present site of Columbia were Richard Gentry, Lewis Collins, John Vanhorn, J.M. Kelly, Peter Wright, Dr. D.P. Wilcox, Samuel Wheller, A.B. Conyers, Charles Burns, Wallace Estill, Minor Neal, William Ridgeway, Peter Kerney, Kemp M. Goodloe, John Cave, Daniel King, James Laughlin, Elijah and Abraham N. Foley, John J. Foster, Adam C. REYBURN, and Willis Boyse.

Sturgeon, Boone Co., MO Aug 8, 1870 Editor Journal:

I was born in Fayette Co., KY, on Mar. 9th 1795. I settled in Boone County in 1819, on the present site of Columbia, I built the first cabin, ever erected in the town. I lived in Boone County over thirty-eight years: I then moved to Lexington MO. where I lived fifteen years, when I removed to my present residence in Audrain five miles north of Sturgeon. I am disfranchised.
ADAM C. REYBURN

Disfranchised,

I. To deprive of a privilege, an immunity, or a right of citizenship, especially the right to vote.

Specifically, in the context of MO, 1870, it means they were Confederate veterans who refused to sign a loyalty oath to the United States.....not an uncommon situation for the time and place.

Whether it was a mark of honor depended, of course, on your point of view.

In MO in particular, there was a real post-war vendetta against ex-Confederates: they weren't allowed to work, own property, and sometimes weren't even permitted to opt to sign (or might not get their rights back even if they did).

Many Confederates took pride in refusing to kowtow to the Union side. There is a folk song from that era whose recurring tag line at the end of each verse is "And I won't be reconstructed, and I do not give a damn."

That vendetta was one of the reasons we ended up with so much outlawry in the state at that time (Jesse James et al): if you can't have a job, have a farm, or vote (the intent being to drive them out of MO entirely), why work within the law?

Proof of sons of Adam C. REYBURN.



Some are proved by census reports. Proof for others are tied to the Obituary of Joseph Henry REYBURN where it says, "He leaves three brothers, Lish, William, and A. K." So we know that Joseph Henry, Losh, William & Adam K. are brothers. If we have evidence that any one of these is the son of Adam C.

then we have proof that all four are sons of Adam C. The obituary being written at time of his death would be considered a reliable record where as something written later by someone might be questionable. Also, the Adam mentioned in the Will of the father of Adam C. could not be

Adam K. because the will was written in 1799 and Adam K. was not born until 1818. So that takes Adam K. out of the question that he could be brother of Adam C. and so now that is out of the puzzle. Dave Rayburn

Dear Ms. Halterman,

I ran across an inquiry you placed on Family Tree Makers web page regarding Adam C. REYBURN. The inquiry wasn't dated so I don't know if you are currently interested in this information, but I thought I'd pass along what I have found.

Boone Co., MO records include several deeds involving REYBURN'S dated 1852-1853 pertaining to Lot 232 in the City of Columbia. The deeds are recorded in Book U, pp.712-713, and Book V pp. 8, 9,12. As nearly as I can tell from the deeds, the children of Elsey REYBURN are conveying their interest in the property to Adam K. REYBURN, who then conveys the lot to William T. REYBURN.

The deeds show the children of Elsey REYBURN to be:  
William T. Reyburn and Nancy, his wife, of Boone Co. MO  
Lewis C. REYBURN and Ann Marie, his wife, of Lafayette Co. MO  
Adam K. REYBURN and Pamela A., his wife, of Ray Co. MO  
Darius E. J. REYBURN, of Lafayette Co. MO  
John D. REYBURN and Margaret A., his wife, of Lafayette Co. MO

A quit claim deed dated March 6, 1854, recorded in Book W, p.303, conveys the interest of Adam C. Reyburn and Elsey REYBURN to Adam K. REYBURN. This deed does not say that Elsey REYBURN is the wife of Adam C. REYBURN. However, a deed dated Jan 18, 1849, recorded in Book R, p.436, records a sale from Adam C. REYBURN and Elsey REYBURN, his wife, to Robert Lemon. This sale involves the West half of the Northeast quarter of Section 35, Township 49, Range 13 (probably a farm).

KISO or KISE or KICE

Regarding your question about proving Kiso and Kice are or are not the same person. Some thoughts for consideration. 1. As we locate more and more documents, this question may answer itself. 2. If we go just by what we know now - my thought is that we must take only what we can prove. As far as I know, we have located only one source of the name for the spouse of Adam C. REYBURN, and that is one marriage record. I note in your "E" you have obtained from an internet source that Kiso, Elsy married REYBURN, Adam C. on 15 Apr 1816 in Fayette County, Kentucky. This spelling seems to be in conflict with the spelling that I found in the book "Fayette County Kentucky Records," Vol III by Michael L. Cook, C.G. Pg. 114 - Adam C. REYBURN to Elsy KISE, with William KISE as surety. April 15, 1816. Unless we can find other sources of her name, this is the best information that we have at this time. If you really want to know how the name is shown on the marriage record, you can write to the County Clerk in Fayette Co. Kentucky and get a copy of the actual record. Then go by that unless you get a better record from some other source.

As you are aware, there are other records that appear to be this same family, i.e. (1) marriage of Adam B. Kemple to Jane Kise, with Adam C. Rayburn as surety; (2) marriage record John Kice married Elsie Raburn; (3) 1850 census report Mary E. Kice enumerated in household w/Adam C.

Right now I do not have any basis for the name "Kiso". Perhaps you have a source for that name. Has the name Kelsey Kiso shown up on any official record? Also, right now I suspect that Kelsey Kiso is really Elsey Kise/Kice - the names sound so much alike and I know from experience that records were made using the spelling as determined from the clerk or census taker based on the way they sounded.



As I mentioned earlier, I personally think it is the best policy to take the best information you can and go with that until better information is obtained. In other words, you can justify the name Elsey Kise or Kice, but as far as I know you cannot justify the use of the name Kelsey Kiso. If anyone proposes Kiso to be correct, then ask for the source. Dave

Notes for Lewis Collins REYBURN:

Regarding the question of the 1830 Census and the name Lewis C. The 1830 Census shows only the name of the head of household and other members of the family are shown by sex and age group. The 1830 Census shows the family as: Adam Raburn Boone Co., MO Pg. 95 Columbia In addition to Adam REYBURN and his wife, there are 5 small male children listed in his household. There is also shown one small female and no slaves. In regard to the question of Lewis/Lewis C. - there is no Lewis REYBURN shown on the MO Census Index as head of a household. Of course the Lewis C. son of Adam C. was only about 10 to 12 years of age in 1830 so he would have been one of the 5 male children listed in the household of Adam C. REYBURN.

On the 1840 Census (which also lists the name only of head of household and others in household by sex and age group) does list a head of household as Lewis REYBURN. Since Lewis C. REYBURN son of Adam C. REYBURN married in 1837, I assume this would be this Lewis C. REYBURN. There was only one Lewis REYBURN listed as head of a household on the 1840 Census index.

Comments: 1. This confirms that Lewis C.'s 1st wife died and that the marriage in 1851 in Buchanan is the 2nd marriage of this Lewis C.

2. Lewis C. REYBURN is reported to have married Mary Herndon 9 Sep 1851 in Buchanan Co., MO (Ref: LDS IGI File, Batch/Film #M514671 Sht 1429)

3. Asa G. REYBURN - son of Lewis C. & Anna Maria (Graves) REYBURN.

4. Lewis A. REYBURN - son of Lewis C. & Anna Maria (Graves) REYBURN. The 1850 showed name only as "Lewis". We now know his middle initial.

5. Marcus W. REYBURN - son of Lewis C. & Anna Maria (Graves) REYBURN. In the letter written by Lewis C. REYBURN in 1860 to his brother, he spelled the name as "Marques" rather than Marcus. I am not sure which is correct. Perhaps later research will clear this up. Right now, I think the best guess is that the father knew how to spell the name better than the Census Taker - so I am going to use the spelling of Marques until better information is found.

6. Dolly E. REYBURN - I believe Dolly E. REYBURN is the daughter of Lewis C. & Anna Maria (Graves) REYBURN. There are two reasons that I believe she is the daughter of Anna Maria rather than Mary:

{On THIS ONE I'm disagreeing after many days of trying to figure this one out I'm going to put Dolly as child of Mary (Herndon) REYBURN until I can find more proof. Joanne HALTERMAN}

7. John REYBURN b. 1863 in MO - son of Lewis C. & Mary (Herndon) REYBURN

8. William REYBURN b. 1856 MO - son of Lewis C. & Mary (Herndon) REYBURN. From the old Letter written by Lewis C., I had calculated that the family moved to California about 1855/1856. The Census taker indicated that William was age 4 and born in MO. The Census Taker may have made a mistake or it may be that they moved to California in early 1856.

We now have it Lucy A. which I believe is the correct name. She indicates she is "S" or Single. She apparently never married - her name still REYBURN and if she had been married and husband died they should have indicated Wid.
  - Note that Adam K. is Director of Bank at age 81!!!! What a man!
  - Blanche - a grand-daughter to Adam is age 17 and single. Her name being REYBURN she would be daughter of a son of Adam K.

The "Conservator" made the following editorial comments on the "notice:"
"Elsewhere we publish a letter from David Whitmer, Sr., an old and well known citizen of Ray, as well as an endorsement of his standing as a man, signed by a number of the leading citizens of this community, in reply to some unwarranted aspersions made upon him. There is no doubt that Mr. Whitmer, Who was one of the Three Witnesses of the authenticity of the gold plates, from which he asserts that Joe Smith translated the Book of Mormon (a fac simile of the characters he now has in his possession with the original records), is firmly convinced of its divine origin, and while he makes no efforts to obtrude his views or belief, he simply wants the world to know that so far as he is concerned there is no 'variableness or shadow of turning.' Having resided here for near a half of a century, it is with no little pride that he points to his past record, with the consciousness that he has done nothing derogatory to his character as a citizen and a believer in the Son of Mary to warrant such an attack on him.

Combs Researcher Michael R. Wilson: The Marion Twp. area was originally known as the "Far West Colony," consisting of land granted to the Mormons in 1833. Unfortunately, however, constant conflicts occurred between the Mormons and other settlers in surrounding communities, with the result being that on 30 October 1839 240 state militia attacked the Mormon community. Mormon leader Joseph SMITH then surrendered to

the terms given to the Mormons by the State of MO, and the Mormons of Far West signed over their property to the militia. "In one week about 6,000 militiamen showed up in Far West for their share of the wealth" (Ibid. The Battle of Crooked River).

I am not sure Esrey is the correct spelling (the spelling, as best I can read it is Esrey, but I am not sure that is the spelling the family used. It is not a name I am familiar with).

After the arrival of the last child who came on Saturday to the bedside, and who told of the ill health of the son, Wray. who was prohibited the pleasure of being with us in the last hours of our dear father's life he said: "Now I'm ready. and Monday morning peacefully slept away to the beautiful home which He said was prepared for him in Heaven Joseph Henry REYBURN was born in Boone County, Mo. Sept. 20, 1828, died at his home near Schell City, Mo. July 25, 1910 at the age of 81 years, 11 months and 5 days. He was married to Margaret Jane Fortney, Dec. 9, 1849, at Columbia, Mo. After the funeral. which was conducted by Pastor Barnes residence, the deceased was lowed to Green Lawn cemetery for interment, and laid to rest beside his wife who had precede him, the hearse being driven by the same friend, Eddie Shr\_\_ who had driven it for his wife years ago. FOUND DEAD.

Sudden and Sad Death of Mrs. J. H. Rayburn, From Heart Failure Sunday Night.

Monday morning news was brought to town that Mrs. J. W. REYBURN had died the night previous at her home one and three fourths miles west of this city. Mrs. REYBURN had been in bad health all winter but Sunday night when she retired she seemed to be as well as usual, and after going to bed laid and talked with her husband for quite a while. She had been to see her son Joseph REYBURN Sunday, who lived about a mile and a half from her home. Monday morning the members of the family arose at 5 o'clock, leaving Mrs. REYBURN lying in bed until breakfast was ready as they had been accustomed to doing all winter. When the morning meal was prepared she was called but did not answer. The second time she was called and again did not answer, and investigation disclosed the sad sequel of her silence she was dead. Her limbs and the greater part of her body was cold when found and evidently she had been dead some time. A messenger was immediately dispatched to town and summoned Drs. Jarvis and Lunsford, who, when they arrived at Mr. REYBURN'S found that she was past the aid of medical skill, and pronounced the cause of her death as heart failure. Mrs. REYBURN'S brother, Weary Fortner, of Columbia died last Friday. The funeral took place yesterday at 2 o'clock at the family residence, the funeral sermon being preached by Rev. A. S. Guinn of the Baptist church; of which Mrs. REYBURN was a faithful member. Mrs. REYBURN was 66 years old and had lived at this place for ten years.

OBIT. Columbia MO Herald, 30 March 1893: DIED. RAYBURN.--In Schell City, MO, March 19, 1893, suddenly, Mrs. J. W. Rayburn, aged 66 years. She was a sister of Wary Fortney, of Columbia, whose death which occurred two days previously was noted in the last issue of the HERALD.

I this quite morning I will endeavor to rite you a few lines to let you hear from me I am well at preasant hoping this few lines may find you all well the family is all well well Brother I have not waited quite as long as you did before answering well we have had a protracted meeting have just closed But will start again the Second Sunday in April our preacher got sick it is Brother Isabell that had the care of the church at Bonfam there was seven additions to the church all of them heds of famleys But too well Brother our garden is planted out that is apart of it our lettuce is up they will plant corn next week Barry will get thru braking in one more day after to day we have had lots of rain this sprind grass is looking well Ann we have 11 young chickens and some more hens set well brother I will tell you my Son Joe and his family is in Calafania at the red bluffe in one of the county of the pacific ocean I never new he was goin until I got a card from his wife that they was thare had landed that eavening Annie father was the cause of them goin he had bin out thar last fall and liked that contrey and wanted to make that contrey his home and he lived with Joe and Annie and he told Joe he would pay all thair way thare if he would go it was like thunder to me when I got the card and I got a letter from Ed and his wife and they was down on the Kansas line waiting for the presadent proclamation so he could go in the okleynahomy to take him up a home they said it was a site to look at the grate numbers of people waiting for the to be spoke I do not know whare Wary is he started to go to hall on the rail road and I have not hird from him since that was about two months ago oh they have chattered fare from me when parants is raising children they give so much truble when they are trampping your toes we think they are truble a ful nuff but when they get to be men and comence scattering all over this Broad world and some that you never expect to see in this world agane that is truble But the all seeing eye of god is thare if they was all good christane I would have hopes of seeing

Joanne sent me your address and I just wanted to thank you in "person" for identifying my Margaret Rayburn as d/o Robert and Jean Logan Rayburn. I'm sure you are correct in this. Of all the Margaret Rayburn's I've found, none could have been a clearer choice. I just didn't have a daughter for Robert and Jean. Daughters have a habit of "disappearing" from research because their names change. Jim Kinsman is a descendant of John Harper and he sent me a little info including the fact that his John Harper b 1734 mentioned Samuel Sams (left him his body clothes) in his will and Samuel Sams witnessed the will. That gave me what I needed to get back to Augusta County for the Rayburn's. I believe you are correct in your placement. I know Margaret's father had to have died when she was young and that John Harper signed the permission for her to marry. I just never connected her to the Robert Rayburn who was killed by Robert McMahan. I have never found out why he was killed, so this will be an adventure to discover. What a terrible thing to happen.

- 32. **Joseph REYBURN**, born Abt. 1682 in Ayrshire, Scotland⁷⁴; died in Moffett's Creek, Augusta Co., VA.. He married 33. **Margaret COURTNEY** Bet. 1703 - 1710 in PA⁷⁴.
- 33. **Margaret COURTNEY**, born Bet. 1680 - 1685 in VA; died in VA.

Notes for Joseph REYBURN:

He sailed from Liverpool to Virginia on August 27, 1698. . At an unknown date prior to 1698, his parents, himself and possibly other children sailed from an unknown port in Ireland, bound for an unknown port in England where they were going to board another ship for America. During the voyage, the ship sank and the entire family except Joseph was lost. His age at that time is not known. Then, in 1698, he is listed as being from Waser, in Staffordshire, near the west coast of England and is apprenticed to Bryan Blundell as a shoemaker for 5 years making him 16 years old at that time. If he had relatives in Waser or if this orphaned boy was taken in by some kind family is not known. Thought to have had 6 or 7 children.

First Rayburn to come to America, was born in England in 1682. His ancestors first came from Scotland, and then from Ireland. He sailed from Staffordshire, England and landed in Augusta, County, Virginia, in 1698. To secure his passage, he came as a "bound" servant, bound out to the Sea Captain whose name was Bryan Blundell. As all emigrants had to have a trade, he gave his trade as a shoemaker. He acquired land in Augusta County, Virginia, married, and raised a family of five or six children, although we are certain only of James and Angy. [From Family History of Rabourn-Ruggles Families)

The next date where I find a Joseph is 1755, Mar 24, when he is named executor of the will of John Nickel. Also in 1755, July 5, a Joseph attested to the transfer of land from Joseph Wright to

Thomas Weddell. This could very well be the same Joseph as he would have been about 70 years old. (Pat Parish 9/9/1997)

Joseph Rayburn born 1682, came to America August 27, 1698 and died here. (reference New England historical & genealogical Register, Volume 64, pages 158 - 161) Shoemaker apprentice to Mr. Bryan Blundell in Virginia for 5 years (age 16) as was usual the case in those days all boys were apprenticed to learn a trade, after which he was a free man with a trade. He married 1703 - 1710 in Pennsylvania to Margaret Courtney.

Quote from letter Parke Jones to Mrs. Wm F. Nienstedt dated 1 March 1981 - "There are many different Rayburns in America, and many different clans, who are descendants of many immigrant ancestors in their own right, so we all are not descendants of one ancestor. There was an Anthony Resburne in Virginia as early as 1635. Whether he was a Rayburn or not, I am not sure. There was a Richard Raibone in Henrico Co. Virginia, circa 1650, who never married but he lived common law with a woman Elizabeth who had several illegitimate children and was denied a pension from her unlawful husband when he died, and I am sure he was not of the Scotch Rayburns from Scotland or North Ireland...."

Quote from letter Parke Jones to E. D. Rayburn dated 8 Sept 1981 - "We find a Richard Rabun- (Rayburn?) living in Henrico Co. VA as early as 1650 but here again I am positive he was of that "Rabun" branch who spread all along the coastal part of Virginia and descendants scattered down into the Carolinas, then to Georgia, Florida, and over in to Alabama, Mississippi and on to Arkansas and finally Texas....."

Joseph Rayburn born in Waser, England in 1682, was early left an orphan..... He came to America in 1698, binding himself out as a shoemaker to pay for his passage to Virginia.....Family tradition gives him five or six children but all that can be located are Angy, who married James Cole, and James, who married Elizabeth _____ in 1732.
